WJWW filtration plant proposal reaches Harrison **Planning Board**

Opponents gear up to stop its new location

The fight for the water filtration plant that is court mandated to bring clean filtered drinking water to all water users in Port Chester and Rye Brook has gotten more extreme even as it moves forward.

The Town of Harrison Planning Board last Tuesday night, Jan. 24, was the latest scene of the clash between two bitterly opposed sides.

On the one hand, Westchester Joint Water Works (WJWW) with its current detailed plans to build the plant on Westchester County Airport (HPN) land adjoining Purchase Street.

On the other, the decades-long bitter opponents to the plant's very existence, billionaire Purchase resident and Purchase Street landowner Michael T. Tokarz's Purchase Environmental **Protective Association** (PEPA) and members of the Purchase Street-based Quaker Friends Meeting House.

At the Planning Board meeting, WJWW consulting engineer Eileen Feldman, P.E., Associate Vice President with Hazen & Sawyer, and WJWW General Counsel Lori Lee Dickson of McCarthy Fingar LLP, presented both the visual and legal requirements for the

Who is Michael T. Tokarz?

Michael T. Tokarz is one of Purchase's (and thus Harrison's) most influential private landholders, which includes his personal estate and that of his Sylvan Development Group.

To find out more about Tokarz, the longtime opponent of the locations for WJWW's court-mandated filtration plant, the Westmore News headed to Google and started searching with this question: what is Michael Tokarz's net worth?

One of the first answers that came up was from www.Benzinga.com, a website that has provided free and subscription services to investors since 2010.

Their reply to the question:

What is Michael Tokarz's Net Worth?

The current estimated net worth of Mueller Water Products, Inc's Director, Michael Tokarz, is estimated to be about \$2.81B. Michael Tokarz owns about 376,499 units of Mueller Water Products, Inc common stock. In the last 14 years at Mueller Water Products, Inc, Michael Tokarz has sold an estimated value of \$145.59K worth.

plant to a board whose responsibility is to make sure the plant design, construction, and landscaping – in short, the site planis in accord with Harrison Town Law.

Planning Board Chair Richard Stout silenced PEPA and Quaker Meeting House members in the audience when they tried to ask questions or make statements, saying this was not a public hearing and comments would only be accepted at a future public hearing that dealt with the site plan and not the location of the filtration plant.

He reminded them that the WJWW was the lead agency on the environmental review and not the Planning Board, and that the environmental review process was over.

Hence Tokarz's, PEPA's and the Quaker Meeting House's political campaign to persuade County Executive George Latimer, his administration, and the County Legislature to put a stop to the proposed land swap that would see the plant built on County Airport land in a different location than the County Airport location they had previously opposed more than a decade earlier.

Tokarz has stated in a letter to Latimer, with copies to a wide range of appointed and elected officials, that he has changed his mind from his opposition to the plant being built on HPN land near land owned by his Sylvan Development Corporation and is now willing to see it there as opposed to the plant's now planned location on another equally sized parcel of HPN land.

This land swap must be approved by both the Legislature and

Michael Tokarz's largest purchase order was 200,000 units, worth over \$950K on September 18, 2009. Michael Tokarz's largest sale order was 9,546 units, worth over \$98.07K on December 13, 2018. Mr. Tokarz has served since 2002 as Chairman of the Board of Tokarz Group, LLC, an investment company, and since 2014 as one of the cofounders of Public Pension Capital, a private equity fund. In 2020, he assumed the role of vice chair of Shield T3, LLC, a COVID-19 testing company owned by the Board of Trustees of the University of Illinois. In 2007, he was honored by the Outstanding Directors Exchange as an Outstanding Director of the Year. Mr. Tokarz earned a Bachelor of Arts degree in economics with high distinction and a Master of Business Administration degree in finance from the University of Illinois."

Readers who peruse the Mueller website will find out that the firm, with a variety of brands, is deeply involved in the infrastructure needed by municipalities to control the distribution of water.

Tokarz also runs The Tokarz Group, which has this description of its founder on its website.

"In 2002, Michael Tokarz decided to leverage his 30 years of experience as a senior investment professional to launch a different kind of private equity advisory firm.

After serving as a General Partner with Kohlberg Kravis Roberts & Co. (KKR) for 17 years, he was ready to assemble an equally impressive team that would exhibit the kind of roll-up-your-sleeves involvement that would be both personally rewarding as well as financially successful. The team included Warren Holtsberg, founder of Motorola Ventures, the venture capital and private equity investment arm for Motorola, Inc., and Bruce Shewmaker, a co-founder of Merrill Lynch Venture Capital Inc. The Tokarz Group Advisers, LLC (TTGA) was up and running.

One of TTGA's first endeavors was to turn around MVC Capital, Inc. by redirecting its investment objectives from start-up IT companies to target traditional mezzanine and private equity investments under the leadership of Michael Tokarz, who became Chairman and Portfolio Manager of MVC Capital, Inc. in 2003.

TTGA became a registered investment advisor* with the Securities and Exchange Commission effective October 31, 2006, before the Fund formally externalized its management to TTGA on November 1, 2006. Since then, TTGA has continued to build an investment team with a top-tier private equity pedigree.

Throughout the same period, Michael Tokarz pursued private investments in small and mid-size businesses, as well."

Michael Tokarz and Paul Kutzy exchange verbal blows

Billionaire Purchase Street landowner and head of PEPA Michael Tokarz has usually stayed in the background of the battle to stop the building of the WJWW filtration plant. Occasionally, instead of having lawyers in his employ or employees of PEPA make his case, he has written carefully crafted letters to elected and appointed officials arguing for the plant's relocation.

But in January, with the launch of PEPA's petition to Stop the Swap on the website change.org, Tokarz took the rare step of making an unfiltered post attacking the plant.

Below is the exact wording of his post, with an equally angry response from Paul Kutzy, manager of the WJWW.

The WJWW is building on the WATERSHED, digging down two to three UNDERGROUND level's, WJWW tested digging down ONLY 18 INCHES DEEP in an ARCHAEOLOGICAL CEMETERY where slaves are interned [sic] WITHOUT HEADSTONES!! WJWW OWNS THERE [sic] OWN LAND as shown in the PETITION PHOTO! WJWW OWNS LAND ADJACENT TO THE AIRPORT LAND ON ONE END AND SYLVAN LAND ON THE OTHER SIDE. I AM THE OWNER OF SYLVAN AND OFFERED TO ALLOW THEIR TRUCKS TO RUN THROUGH MY SUBDIVISION, SYLVAN ROAD, AVOIDING THE WATER SHED AND THE ARCHAEOLOGICAL CEMETERY.

Response from WJWW Manager Paul Kutzy

This statement by Michael Tokarz is without merit, insincere and irresponsible. The special interests who oppose the construction of the filtration plant on the current site are using scare tactics and spreading either misleading or misinformation in an effort to confuse and dupe the public.

Former Rye Town Councilman David Gelfarb is now involved

More than three years ago, WJWW coordinated with the New York State Historic Preservation Office (SHPO) and an in-depth SHPO Phase 1 Archaeological Survey was conducted in accordance with the standards of the New York Archaeological Council. After reviewing the Survey, OPRHP concluded that "it is the opinion of Office of Parks Recreation and Historic Preservation (OPRHP) that no properties, including archaeological and/or historic resources, listed in or eligible for the New York State and National Registers of Historic Places will be impacted by this project." Further, the OPRHP stated that "it is the opinion of the New York SHPO that no historic properties, including archaeological and/or historic resources, will be affected by this undertaking."

WJWW's Rye Lake Filtration Plant is required to provide drinking water that complies with standards for the protection of public health, to the up to 100,000 residents and other consumers in Westchester County that WJWW serves.

and formerly a Westchester County Legislator, Rye Town Councilman and Rye Brook resident, asked a series of questions of Dickson regarding the status of the legal issues with the County and New York City and New York State environmental officials.

"The County and WJWW are circulating a draft of a contract," said Dickson. "That contract will indicate that the closing cannot occur until after all discretionary approvals have been obtained in order for the plant to proceed as proposed. What we're looking to do is to commence the review process, but we are hoping the Planning Board can commence their internal technical review."

She added: "You have a complete environmental impact statement ... in front of you. It contains a deeply detailed alternatives chapter. You've been provided all the information. You've been a partner in the entire process. We are just hoping at this point that the approval review can start. Of course, it would be at the expense of WJWW."

Gelfarb: "What are you doing about zoning variances?

Dickson: "It would be premature at this point to ask for variances."

Gelfarb: "You need to have a vote from the executive branch ...(and) the County Legislature as well (for the land swap). How long will (it take to get) to the next stage?"

Dickson: "We anticipate no longer than June to receive authorization to execute that contract of sale. Everything must be in place."

At this point, Chairman Stout said his board would not take any action "until the ink is dry on the contract of sale."

The campaign to "Stop the Swap"

While the Quaker Meeting House and PEPA team at the meeting caucused afterwards to plan their next steps vis à vis the Harrison Planning Board, their public campaign to persuade lawmakers not to approve the land sale reached a crescendo as Tokarz posted an inflammatory post on a www.change.org petition to stop the sale, accusing the WJWW of attempting to build on land "where slaves are interned [sic]."

This prompted WJWW Manager Paul Kutzy to issue a statement denouncing Tokarz's post as "without merit, insincere and irresponsible. The special interests who oppose the construction of the filtration plant on the current site are using scare tactics and spreading either misleading or misinformation in an effort to confuse and dupe the public." (See adjoining box for the full dialogue.)

The efforts described by Kutzy are taking the physical presence of political yard signs (see accompanying photos) scattered around public and private land throughout the Town of Harrison and in other locations, such as the front yard of a Port Chester resident.


Additionally, Tokarz via his PEPA team has published a map that shows the proposed WJWW filtration plant "underwater" within the boundaries of the Kensico Reservoir, boundaries that in their map show a stretch of the main runway at HPN also "underwater." (See adjoining PEPA map.)

The campaign has resulted in elected officials at the local and county level avoiding comment on the urgent legal and health need for the filtration plant. Most recently, WJWW Board Chair Murphy has yet to be successful in establishing direct phone communication with Rye Brook's Mayor Jason Klein, whose day job is with the County Department of Parks, Recreation and Conservation.

Absent in this whole controversy are the voices of those residents of Rye Brook, Port Chester and other locations served by water from the WJWW. At this point their sole elected vocal spokesman is Murphy.

His work, and that of Kutzy and his team, is spurred not only by their desire to build the plant, but by state court fines for the so far non-construction now well above \$69 million, not including prospective federal fines for similar failure.
